## DECLARATION OF KENT KOBERSTEEN IN SUPPORT OF DEFENDANTS' CROSS-MOTION FOR PARTIAL SUMMARY JUDGMENT AND IN OPPOSITION TO PLAINTIFFS' MOTION FOR PARTIAL SUMMARY JUDGMENT AS TO NUMBER OF WORKS INFRINGED

KENT KOBERSTEEN declares as follows, under penalty of perjury:

- 1. I am the director of photography of the National Geographic Society (the "Society") and a senior editor of the National Geographic Magazine (the "Magazine"). I respectfully submit this declaration in support of Defendants' Cross-Motion for Partial Summary Judgment and in Opposition to Plaintiffs' Motion for Partial Summary Judgment as to Number of Works Infringed. I make this declaration based on personal knowledge except where otherwise indicated.
- 2. The Society is a nonprofit scientific and educational organization dedicated to the increase and diffusion of geographic knowledge in its broadest sense. I joined the Society in September 1983 as an illustrations editor. In that capacity, I worked with freelance and staff photographers who were photographing stories for the Magazine. I worked with the photographers in planning their photographic coverage, reviewing preliminary work as it came in, and editing the final photographs for the story. I also participated in the layout of the

stories and coordinated with other departments of the Magazine that prepared other visual portions of the periodical, such as maps, drawings and the like. In September 1987, I joined the photographic division as assistant director of photography, and became the associate director of photography in 1995. In February 1998, I was promoted to director of photography. As director, I am involved in planning Magazine stories at the conceptual stage, I select and assign the photographers, and I am responsible administratively for managing the assignment photographers who shoot stories for the Magazine.

- 3. Each issue of the Magazine is a collective work comprising several stories. Each story is comprised of both photographs and text. The Society frequently retains freelance photographers, like Mr. Greenberg, to create the photographs for these stories, and has done so for decades.
- 4. When the photographer has completed the assignment he or she will have submitted many more photographs than can be used in the story. The Magazine staff then selects those photographs that will be published in the story and arranges them visually. My understanding is that this procedure has been followed for decades.

5. Pursuant to 17 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.
