phrases, or clauses identified by the parties for construction in this matter as follows:

U.S. Patent 5,790,512

Claim Term Phrase or Clause	The Court's Construction
information unit (claims 1,3)	A portion of an information stream.
information area (claims 1,3)	A place on an information carrier where an information unit is stored.

U.S. Patent 5,745,641

Claim Term Phrase or Clause	The Court's Construction
video blocks (claims 1,4,6,8)	A subdivision of a picture sequence.
entire encoded picture information (claim 1)	Sufficient data to reconstruct each pixel of a picture.
header (claim 1)	A part of a block containing reference information.

referring to the location (claim 1)	Referring to the position.
time code (claim 4,6,8)	An indication of when a picture is displayed.
reference instant (claim 4)	A specific point in time.
pointer code (PC) (claims 6,8)	A code for indicating a specific sector.
Sector offset code (claims 6,8)	A number that represents a correction of the sector number corresponding to the time code.
