3. Among his duties as Business Manager is supervision of the operation of the Publications Office of the Electrical Engineering Department, a responsibility which he also held during the months of April and May, 1959.

4. One of the functions of the Publications Office of the Department of Electrical Engineering is to print and distribute the various reports required by research contracts and grants under which research work is performed by the Department.

5. In April and May, 1959, Miss Marjorie Johnson was in charge of the routine operation of the Publications Office. Miss Johnson reported to him as her supervisor.

6. In April and May, 1939, the policy of the Department of Electrical Engineering was generally to make available to interested responsible parties copies of research reports which emanated from the Department, provided that there was no restriction imposed on distribution, either by law or by the sponsor of the work reported therein. Once an unrestricted report had been issued to the sponsoring agency, requests for copies from the public would usually be honored as long as extra copies were available.

7. Prior to the issuance of a report, however, the policy of free dissemination and accessibility to reports did not apply with respect to requests from the general public. In general, issuance of a report was indicated by mailing or otherwise delivering the necessary copies of the report, as called for by the research contract with the sponsoring agency.

8. Although a request for an issued report from a responsible member of the public would usually have been granted after the report in question had been delivered to the sponsoring agency, such a request for a report prior to its being supplied to the sponsoring agency

presented a policy question to be resolved in each case by consultation with the Project Director of the Department in charge of the work, as well as with an appropriate official of the sponsoring agency. There was no established policy which permitted premature distribution of research reports, and no implication that permission for premature distribution of copies to anyone outside the Department or the sponsoring agency would be granted in any particular case.
